4. Pre-bid meeting shall be held at Office of the Prime Ministers and Council of Ministers at **2 August, 2024 (Shrawan 18, 2081) at 12:30 PM.**
5. Interested Bidders shall submit the electronic Bids through [www.bolpatra.gov.np/egp](http://www.bolpatra.gov.np/egp) to the above office of Office of the Prime Minister and Council of Ministers, Singhadurbar, Kathmandu on or before **12:00 PM on August 18, 2024 (Bhadra 2, 2081).**
6. The Bids shall be opened in presence of Bidders' representatives who choose to attend on 2:00 PM on **August 18, 2024 (Bhadra 2, 2081).** at the office of Office of the Prime Minister and Council of Ministers, Singhadurbar, Kathmandu. Bids must be valid for a period of 90 days counting from the day of bid opening and must be accompanied by bid security, amounting to a minimum of NRs. **130,000 (One Hundred and Thirty Thousands Only),** which shall be valid for minimum 30 days beyond the bid validity period.
7. If the last date of purchasing and /or submission falls on a government holiday, then the next working day shall be considered as the last date. In such case the validity period of the bid security shall remain the same as specified for the original last date of bid submission.
